1	1. The total number of sections shall be restricted to 48 and any further increase shall require prior permission of the Board and shall be subject to compliance with the affiliation bye laws of the board.			
2	2. The school has applied in switch over category, which is not correct as it is not yet affiliated to any other school Board.Hence for all purposes in future this shall be treated as a case of fresh affiliation upto the Secondary level.			
3	3. The school shall conduct mandatory training of its teachers with CoE Bengaluru within 3 months and submit compliance on SARAS.			
4	4.The school shall renew all mandatory certificates from time to time.			
5	5. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities.			
6	6. The school shall not remove the mandatory disclosure section and the videograpghy links from its website.			

The above is subject to fulfillment of the following conditions:-
