Bangalore City, Suddaguntepalya, Dharmaram College Post An advisory letter has been issued by the Fire and Emergency Services Department dated 05-09-2020 as per your request for Christ School Building with 19.40 meters height ground floor & Four Floors constructed here.

In your letter of reference (2). The installation of fire extinguishers in the said school building has been completed and requested the Fire and Emergency Services Department has to issue a certificate of completion.

As per your request. On 26-03-2024, Fire and Emergency Services officials inspected the school building constructed at Dharmaram College Post, Suddaguntepalya, Bangalore City. As per the advisory letter issued by the Department of Fire and Emergency Services, Fire Protection and Control. Installation of fire extinguishing equipment and safety measures have been fully implemented in the educational building and the training of the employees/staff in the said building is pending, as soon as receiving the completion certificate from the department they will arrange the firefighting training for their staff without any delay.

Hence the city of Bangalore. Fire Protection and Control and Fire Extinguishing Equipments for Christ School Building with 19.40 meters height and Four Floors constructed at Suddaguntepalya, Dharmaram College Post vide Fire and Emergency Services Department Advisory Letter No. GBC(2)193/2022- 23 dated 05-09-2020 Implementation and protection measures to be strictly followed and as agreed in your cover letter dated 27-03-2024, fire fighting equipments to be kept in good condition and appropriate training for 40% of the staff/employees in the building on fire protection and control measures, at R.A.Mundkur Fire and Emergency Services Academy, Bangalore within 3 months. A certificate of Completion Report is issued by the Fire and Emergency Services Department on condition that arrangements are made to obtain it.

This Certificate of Completion shall remain in force for a period of one year from the date of its execution. And then it is said to be renew the certificate.

Also if in any case the fire fighting and firefighting equipments installed as per the recommendation of the department are found to be not in good condition or safety measures are not strictly followed or any additional structures are constructed in the open area around the building as per law, or any kind of permanent/temporary obstructions are caused. It is indicated that this 'completion' certificate will be void and further action will be taken within the framework of law.
